

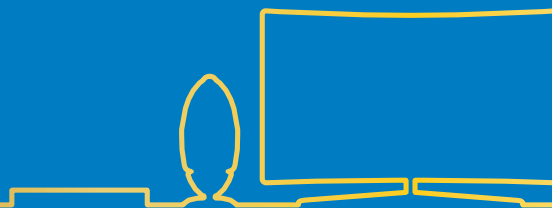

### The Promoter

- The Promoter is Samsung Electronics (UK) Limited, Samsung House, 1000 Hillswood Drive, Chertsey, Surrey, KT16 0PS (the "Promoter" or "Samsung").

### Promotion Period

- The Promotion will commence at 00:01 on 9th June 2016 and will continue until 23:59 on 24th August 2016 (the "Promotion Period").

### Offer

- Participants who:
  - during the Promotion Period purchase a brand new Samsung UHD TV listed below from an authorised retailer (either in store or online) in UK or Republic of Ireland ("Participating Retailer"). Certain retailers are specifically excluded, as set out in paragraph 5 below; and
  - subsequently purchases one or more of the qualifying AV products listed below from the same store (i.e. at the same address and from the same retailer) or website within 28 days of purchasing the Samsung UHD TV ("Additional Product"), shall be entitled to claim a cash reward by redemption in accordance with the claims process set out in clauses 9 to 16 below ("Reward").

- The amount of the Reward shall be either: (a) the potential sum relevant to the UHD TV purchased, as shown above; or (b) the value of the Additional Product(s) purchased from the same store or website, whichever is the lower amount. The Reward paid shall never exceed the potential sums shown above.
- Purchases from auction websites (e.g. eBay), marketplace sales through retail websites (e.g., E-Buyer, Amazon Marketplace or Play Trade) or through Costco, Electro Centre, or Brighthouse are specifically excluded from this Promotion. Other retailers may not be participating, and Participants must check prior to purchase whether their retailer is a Participating Retailer.
- No products used to claim in this Promotion (whether the TV or the Additional Product) may be used to claim in any other Samsung promotion. Products used to claim in other Samsung promotions may not be used in this Promotion.

### Eligibility

- To be eligible to participate in the Promotion, Participants must be a UK or Republic of Ireland resident aged 16 or over. A UK bank account is required for the Reward paid in pounds sterling, and an Irish bank account is required for Reward paid in Euros.
- Employees or agents of the Promoter or their families or households or anyone professionally connected to this Promotion are not eligible to enter. This Promotion is only available to consumers (e.g. not to any business or reseller).

### Claims

- Claims must be submitted no earlier than 14 days from the date of purchase of your Samsung UHD TV and claims must be received within 28 days of the Participant purchasing the Additional Product. Purchases for Additional Products made 29 days or more after the purchase of the Samsung UHD TV are not eligible as detailed in paragraph 3 (b) and will be automatically rejected. The date of purchase counts as day one.
- The final date for claims to be made is by 23:59 on 21st September 2016.
- In order to participate in the Promotion and claim the Reward, Participants must visit [www.samsung.com/uk/offer/rewards](http://www.samsung.com/uk/offer/rewards) and click claim now. Participants must enter the following information;
  - their name, address, postcode
  - their email address
  - the model of TV purchased (from a drop down list)
  - the TV serial number
  - the store of purchase including location (or the web address of retailer, if purchased online)
  - the date the TV was purchased, Price paid
  - the Additional Product(s) purchased: Item(s), Model(s) and Serial Number(s), Price paid
  - the date the Additional Products were purchased
  - the invoice/receipt number
  - bank details
  - opt in for marketing communications
 and then upload a scanned copy/image of their receipts or invoices for the TV and the Additional Product(s) purchased.
- Only one claim can be made per qualifying UHD TV purchased, however, this claim can include multiple Additional Product purchases. It is not possible to add further Additional Products after the claim has been made.
- Participants will be sent an email to confirm that their claim is valid (or not valid with a reason provided). The Promoter will aim to send this email within 7 days of the claim being received.
- Payment of the Reward will be made by bank transfer directly into a nominated UK or Irish Bank Account.
- We will aim to process a bank transfer within 30 days of a validated claim.
- All claims must be made by the Participant, and must not be made through agents or third parties.

### General

- Following the Participant's purchase of a qualifying UHD TV and Additional Product(s), where the Participant returns any or all of those products:
  - before submitting a claim, the participant will not be eligible to submit a claim; or
  - after submitting a claim, the claim will be invalid and the participant must immediately call: 0345 2160 032 to cancel the claim. The Promoter reserves the right to check with the retailer whether a product has been returned and, by submitting a claim, the participant provides consent to the Promoter to do so. The Promoter reserves the right to report suspicious activity or claims to the police.
